Regulation (EU) 2023/998 on the general safety of products "GPSR"

Given that the cosmetics sector is in fact regulated at European level by EU Regulation 1223/2009 and its subsequent regulatory provisions, which contain the same objectives set out in the regulation in question on product safety, the application of which starts on 13 December 2024, no obligations other than those already in place and implemented by M.MAGI SRL are foreseen.

However, M.MAGI SRL wishes to point out and recommend:

- **The most** effective way to check the quality of a cosmetic product and your individual safety is to read the list of ingredients on the label. The description of the components is done following an international standard: the INCI (International Nomenclature of Cosmetic Ingredients).
- **Carefully** read the indications and instructions printed on the package, on any leaflet, on any manual for use by the beauty operator, or on the website www.mmagi.it.
- **Hair** removal product in a metal jar with safety lock and aroma-saving cap.
- **External** use.
- **Product** intended for professional use by an adult audience: keep away from children.
- **Sugary** mass for MONODEPIL G, resinous mass for DI SANA PIANTA and SILK WAX, to be dissolved, as indicated in the information media indicated above, for exclusive professional use by personnel qualified for the profession, who based on their science, knowledge and experience are able to use it in the right and correct manner.
- **It** is advisable to carry out a simple test before using the product on a small portion of the part to be epilated, especially for the most sensitive subjects, and wait the following 24 hours to ascertain any allergic reactions.
- **If** the product should inadvertently come into contact with eyes and/or mucous membranes, rinse the affected area thoroughly with fresh water.
- **If** the product should be inadvertently ingested due to some incorrect maneuver, take the product composition/ingredients, printed on each primary or secondary package, to a poison center of a hospital. In the absence of hospitals, induce vomiting.
- **Heat** the wax carefully following the instructions provided. After heating, mix the wax thoroughly and check the temperature to avoid burns.
- **Apply** a thin layer of wax in the direction of hair growth, then immediately press the strip on top.
- **Remove** the strip quickly and decisively, pulling in the opposite direction to hair growth. You can reuse the same strip if necessary.
- **Avoid** applying the wax more than once on the same area.
- **To** remove any wax residue, simply use water for MONODEPIL G and oil for DI SANA PIANTA and SILK WAX.
- **Make** sure you never leave the product unattended during the heating process and always keep it out of reach of children.
- **Apply** to healthy skin, therefore free from wounds, irritation, chapping, acne, pimples, moles, varicose veins or capillary fragility, sunburn or other types.



Italian cosmetics for well-being

- **Not** recommended to use for the elderly or diabetics.
- **Do** not expose yourself to the sun after hair removal. Also do not use deodorants, perfumes or alcoholic lotions after hair removal on the treated skin.
- **Do** not exceed the application temperatures of the product in relation to the type and sensitivity of the skin.
- **Take** care to open the jar carefully and attentively, to avoid possible scratches or wounds. The jar should be closed after use with the aroma-saving cap provided for this purpose.
- **Do** not exceed, from the moment of opening the product package, the time of use of the product indicated on the package by the PAO, of 12 months.
