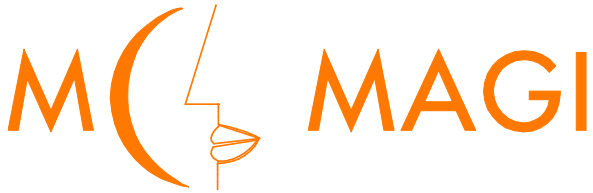


Regulation (EU) 2023/998 on the general safety of products "GPSR"

Given that the cosmetics sector is in fact regulated at European level by EU Regulation 1223/2009 and its subsequent regulatory provisions, which contain the same objectives set out in the regulation in question on product safety, the application of which starts on 13 December 2024, no obligations other than those already in place and implemented by M.MAGI SRL are foreseen.

However, M.MAGI SRL wishes to point out and recommend:

- **The most** effective way to check the quality of a cosmetic product and your individual safety is to read the list of ingredients on the label. The description of the components is done following an international standard: the INCI (International Nomenclature of Cosmetic Ingredients).
- **Carefully** read the indications and instructions printed on the package, on any leaflet, on any manual for use by the beauty operator, or on the website www.mmagi.it.
- **Product** for an intense facial cleansing in two phases: F1 first phase gel + F2 second phase liquid with powder contained in the cap to be precipitated into the liquid below at the moment of use, after intense shaking to ensure that the powder is completely dispersed in the liquid below.
- **External** use for exclusive professional use by personnel qualified in the aesthetic profession, who based on their science, knowledge and experience are able to use it in the right and correct manner on an audience of adults: keep out of reach of children.
- **F1 Specific Gel** (Phase 1) - as already indicated on the label and on the website,
- **F2 Liquid + Active Powder (Phase 2)** - with active ingredients in powder form contained in the cap.
- Preparation of the 10 ml bottle – Screw the cap on until the undercap containing the active powder breaks and it will fall into the liquid underneath. Once the powder has fallen, shake the bottle vigorously with the cap still on until the powder has completely dispersed into the liquid underneath. At this point, remove the cap and start using the product by massaging it onto the affected parts of the face.
- **Application:** carry out a simple test before applying the product on the entire face, especially for the most sensitive subjects. Test on a small portion of skin, on the forearm or neck, first the F1 gel alone, then the F2 liquid, activated with the powder placed on the cap, and finally the F1 phase and the F2 phase combined together, and wait the next 24 hours to see if there are any allergic reactions to the individual phases or to the F1 and F2 phases combined together. If no reactions occur within 24 hours, the product can be used without problems. If there is any reaction, do not use the product.
Use the product on healthy skin, it should never be used on damaged skin such as wounds, burns or abrasions.
- **After** carrying out the cleansing treatment, natural or artificial sun exposure is not recommended. In any case, always apply adequate sun protection after the treatment, especially if you intend to go outdoors.
- **Avoid** or proceed with extreme caution and attention, during the treatment, in the orbicular area of the eyes and mouth.
- **If** the product should inadvertently come into contact with the eyes and/or mucous membranes, rinse the affected area thoroughly with fresh water.
- **If** due to some incorrect maneuver the product should be inadvertently ingested, go to a poison center of a hospital with the composition/ingredients of the product, printed on each primary or secondary package. In the absence of hospitals, induce vomiting.
- **After** applying the product to the face, in the quantity and times indicated in the instructions for use, it must be removed with sponges dampened with water.



Italian cosmetics for well-being

- **Do** not exceed the times and quantities of product to be applied, in relation to the type of skin, indicated.
- **Single-use** product to be used in a single and single treatment application.
- **The** PAO rules do not apply to the product as it is disposable, for one single treatment application.

In short:

- ✓ Periodic deep cleansing and regenerating treatment with high skin tolerability;
- ✓ Based on AHA 12 % of Italian fruit acids with exfoliating, regenerating and smoothing action;
- ✓ Protects collagen: firmer skin;
- ✓ Stimulates fibroblasts to produce new fibrils: younger and smoother skin;
- ✓ 10 ml PET plastic bottle and 15 ml PE tube;
- ✓ For external use only on the face, keep out of reach of children;
- ✓ Avoid sun exposure and tanning for 1 week before applying the product;
- ✓ Perform a patch test for those undergoing the treatment for the first time;
- ✓ Avoid the sun for 48 hours after the treatment;
- ✓ Gently apply the F1 and F2 treatment products to the face in succession as indicated in the explanations on/in the package after cleansing the face;
- ✓ Respect the times and methods of application of the product as indicated;
- ✓ Product not to be ingested;
- ✓ Apply on healthy skin, avoid contact with eyes, mucous membranes and open wounds;
- ✓ Store the product in a dark, cool and dry place;
- ✓ Do not expose the product to high temperatures;
